Model Release - model release

Detailed information on why a model release is needed, how to fill it out, a sample filled-out release, and a universal model release form for all photo banks.

What is a model release? A model release is an agreement between a photographer and a model stating that the photographer has exclusive and full rights to use the photographs taken of the model. This means that the photographer can do whatever they want with the photos within the bounds of the law, including transferring them to third parties, selling them, and using them for advertising purposes.

Why is a model release needed? A model release is necessary to prevent conflict situations and potential claims regarding the use of photographs. For example, you may have photographed a woman, verbally agreed that you can use the photo however you want, and placed it in a magazine for cosmetics advertising. Suddenly, the woman demands money from you for using her photo and threatens to sue if you refuse. To avoid such problems, a model release is signed.

In which cases is it necessary to fill out a model release? For photo banks, a model release is a mandatory attribute for all photographs you sell under a Standard or Extended license and that feature recognizable individuals. "Recognizable" means that either the person's face is visible or some characteristic features are identifiable, such as tattoos.

Another interesting point is that if a photographer sells a photograph featuring themselves, they need to sign a release with themselves!

How to correctly fill out a model release? Each photo bank has its own template for a model release. However, this does not mean that the photographer and model must sign a separate agreement for each photo bank. You can use a universal form that will be accepted everywhere if filled out correctly. Proper completion involves having information in all fields of the release form printed in English.

Here is a demo sample of a filled-out model release:

The form of this release is taken from Lori's photo bank. The choice is justified by the fact that, firstly, it contains all the necessary fields, making it suitable for all photo banks. Secondly, it has a duplicate in Russian, which allows people who do not speak English to understand its contents. From personal experience, I can say that this is really convenient. Therefore, I use this version of the release with all models.

Workflow with model release for photo banks:

- 1. Before photographing people, sign a model release with each of them.
- 2. Scan this document and upload it to your computer.
- 3. Add a thumbnail of the model's face to this scan in Photoshop or any other graphic editor and save it in jpg format.
- 4. Upload the final release to the photo bank. This step is often combined with step 5.
- 5. Attach the release to all photos featuring the respective model. This option is available in your seller's personal account on each photo bank. When submitting new photos for review, the necessary model release is selected from the corresponding list.

The Model also consents to the use of any narrative, text, audio, sound, action, program, effect or other matter that may be used in connection with the Images and the permitted uses, and irrevocably vaives any right that the Model may have to inspection or approval of any of the deliverables or uses contemplated in this Release. In consideration of the Model's consent and release, the Photographer will use reasonable commercial efforts to ensure that the Images will not be used for any pornographic, obscene, defamatory or libelous purpose.

The Model hereby irrevocably releases the Photographer and each of the Authorized Parties, and any and all other parties acting under right, title, assignment, grant or license from the Photographer or the Authorized Parties, from any liability, costs or expenses arising by virtue of: (i) any blurring, distortion, alteration, optical fillusion or use in composite form, whether intentional or otherwise, that may occur or be produced in the creation of the images or in any subsequent use, processing or publication thereof; and (ii) any claim or cause of action, now known or later developed, resulting from or in connection with any use of the images contemplated by this Release, including without limitation, any claims for libel, defamation, invasion of privacy, or breach of publicity or other property rights.
